A. Using Bohemia Bicycles Electric Bikes

A.1. Electric bicycles may only be rent after submitting at least one of the following documents:

- Valid ID card,
- Valid passport

And another identity card (insurance card, driving license etc.)

A.2. The Lessees must be persons over 18 years of age.

A.3. Prior to takeover, the Lessee must thoroughly examine the electric bicycle and try it off the road to check for any noticeable defects. Later complaints will be disregarded. The condition of the electric bicycle will be recorded in an up-to-date photograph.

A.4. Should you find any defects or lacks during the use, you are obliged to report them when returning the bicycle.

A.5. It is forbidden to make any changes to the electric bicycle without the consent of the operator.

A.6. It is forbidden to pass or lend the electric bicycle to any persons not included in the Agreement.

B. Equipment of the Bohemia Bicycles Electric Bicycle

Electric bicycle is understood as a bicycle equipped according to Appendix No. 13 of regulation No. 341/2002. The electric bicycle is also provided with a chain lock and a cycle helmet with LED ride direction indicators.

C. Basic Rent Period, Price and Damage Payment

C.1. The BBicycle rent fee is CZK 999 including VAT for 1 hour, without the payment of a refundable deposit. The vintage electric bicycle with woman frame rent fee is CZK 599 including VAT for 1 hour, without the payment of a refundable deposit.

C.2. If the rent period is exceeded, the Lessee must additionally pay another one hour. In the opposite case, when the already paid time limit is not drawn completely, there is no refund.

C.3. In the case of a slight deterioration to the electric bicycle (bent handlebars, dinged tanks or fenders, abraded paint, damaged tires and wheels, damaged front or rear lights, damaged brakes, damaged or lost paddles), the Lessee must pay damage amounting to CZK 2,000 upon the return of the electricity bike.

C.4. In the case of a sever deterioration to the electric bicycle (torn saddle, damaged motor, damaged or lost battery, front fork deformation, damaged dynamo), the Lessee must pay damage amounting to CZK 7,000 upon the return of the electric bicycle.

D. Responsibility

D.1. To ride a rented electric bicycle is at one's own risk, and the Lesser bears no responsibility for damage caused by the rented item to his or her own property or to other movable or immovable items, or for a damage caused to other persons during the entire period of the rent, or for the Lessee's health during the entire period of the rent.

D.2. The Lessee takes over the responsibility for all electric bicycles stated in the Agreement of Short-Term Rent signed by the Lessee, as well as for any persons using the electric bicycle specified in the signed Agreement, if such persons are children and persons under 18 years of age.

D.3. After signing the Agreement, the Lessee takes over any responsibility for the rented subject-matter until the moment of returning the item to the Lessor.

E. Solving of Serious Situations

E.1. In the case of an accident, the Lessee may use the integrated rescue system by calling 112.

E.2. In the case of the electric bicycle or its parts (e.g. equipment), or in the case of its more severe deterioration caused by a third person, the Lessee is obliged to immediately notify the Police of the Czech Republic of the event by calling 158, or a police service, and subsequently submit a report of notification of the incident.

The Operating Rules are part of the Agreement of Short-Term Rent, and by signing, the Lessee agrees to perform in its entire extent.
